Personal data collection and processing

Registering with forms on DOBA websites

When registering for events and activities or enquiring for more information about a specific subject on the DOBA website, your personal data, contact information and other data which you enter in the online form are collected in addition to your IP address.

In accordance with the Personal Data Protection Act (hereinafter ZVOP-1), the data controller may process personal data if personal consent of an individual is provided. In the event of using the DOBA website, personal consent of an individual shall be deemed obtained through the user's action of entering their personal data in the online form and sending the data therefore confirming that they agree with the Declaration on the Protection of Personal Data. The data controller does not assume any responsibility for the credibility, accuracy and up-to-dateness of personal data and contact information provided by the user. As the user of the DOBA website, you shall see to the accuracy and up-to-dateness of all provided information in the context of the DOBA website.

DOBA shall process the personal data, which were collected with the user entering them in the online form, for the purposes for which users of DOBA websites submit these data (conventional, electronic and telephone communication and notification, sending of information, material and invitations to DOBA events, actual applications for enrolment, internal statistical processing, segmentation, analyses, and preparations of reports).

Providing personal data to third parties
